### How to achieve sustainable transitions?

The irresponsible patterns in which the global community produces, processes, and consumes natural resources and distributes the wealth and well-being derived from these resources are destroying biodiversity, the environment, and the climate.

At the same time, they also drive armed conflicts, displacements and human rights violations, destabilise societies, exploit workers and exacerbate social inequality. To advance sustainability and social justice, many stakeholders need to change course: governments, regulators, companies, financial institutions, and consumers, to name some of the crucial actors. For all of them, transitioning is difficult and inhibited by existing rules and regulations, engrained habits and practices, outdated technologies, and vested interests.

In these complex dynamics, as a civil society organisation, trade union or public authority you want to identify effective strategies or policy proposals - whether your objectives are related to the environment, human rights, tax justice or animal welfare. The trainings offered by Profundo will support you with this challenge by increasing your understanding of how important corporate, financial and government actors operate and how they can be influenced to advance sustainability and social justice. With this knowledge, you can exert influence where it is most effective.

### Finance and Training theme 1 sustainability

Understanding how finance can drive corporate change

Understand the foundational concepts of finance, the different types of financial institutions (such as banks, pension funds, insurers and asset managers) and the intersection between finance and sustainability. Learn the language of finance and explore how you can effectively influence financial institutions to limit climate change, promote labour rights, or stimulate companies to give more attention to other sustainability topics.

Designing responsible investment and credit policies

Understand what international standards and best practices can be followed by banks and investors to develop good policies that promote responsible investment and credit practices. This training can be customised to your focus topic or sector: mining, climate change, human rights, garments, livestock, or biodiversity, among others.

Sustainability in financial regulations

Increasingly, central banks and other regulators see the importance of financial institutions acting on sustainability issues, especially climate change and biodiversity, while they are starting to look at labour issues and human rights as well. Understand the trends and best practices in financial regulations and taxonomies worldwide, compare them to the regulatory framework in your country and look for opportunities for improvement.





### Developing impactful case studies

Case studies can be a powerful tool to hold banks and investors to account. Learn what the characteristics and elements of an impactful case study are, how you can develop it with the support of research professionals and how you can use it in you campaigning and lobbying work.

## Holding corporate power to account

### Training theme 2

The landscape of CSR disclosure frameworks

Dive into the world of corporate social responsibility (CSR) disclosure and due diligence frameworks, both mandatory and voluntary, such as TCFD, CSRD, GRI, ISSB, TNFD. CSDDD. etc. Understand what these disclosure frameworks expect of corporates in the sectors you are focusing on, learn about their limitations, and question what is needed to ensure this disclosure frameworks drive changes in the real economy.

Researching companies for social justice

Equip yourself with the skills to investigate and report on corporate sustainability issues. Understand methodologies for uncovering and highlighting the social justice impacts of corporate activities. Learn how to collect data from public sources, databases and interviews with workers and other stakeholders.

Privatisation of public services

Public services, such as healthcare, water supply, education, child care and public transport, are privatised across the world, with strong impacts on accessibility, service quality, remunerations and social equality. Understand which companies and financiers are behind these privatisations and explore how they could be influenced.



### Carbon and biodiversity offsets

Many companies circumvent their direct responsibility regarding the climate and biodiversity by financing carbon and biodiversity "offsetting" projects in the global South. However. carbon offset credits undermine meaningful climate action, and often violate the rights of local communities and threaten their livelihoods. Learn about the origin of the voluntary carbon market, its purpose and its current limitations. And explore what can be done to avoid the negative social impacts of offsetting projects.

### International Training theme 3 commodity supply chains

Understanding international commodity supply chains

Examine how international commodity supply chains are organised. Explore the power relations in these chains, the market dynamics and the impact of government regulations like EUDR, which impact entire value chains. Understand how to promote fair labour practices, biodiversity protection and other sustainability objectives throughout the supply chain.

Women and migrants in supply chains

Investigate which role women and migrants play in many international commodity supply chains. Learn about gendered impacts and gendered approaches to analyse the sustainability of supply chains. And examine what different stakeholders can do to improve the working conditions and ensure a fair compensation for vulnerable groups in international supply chains.

Profit distribution in international supply chains

Only a small proportion of the profits of internationally traded commodities benefits the primary producers, often smallholders and workers in the global South. This is why midstream companies, like traders, and downstream companies, like brand manufacturers and retailers, should play a crucial role in achieving equitable change. Explore how the analysis of the profit distribution in international supply chains can support you to challenge unfair divisions of income and power.



### Exposing tax avoidance

To be able to offer education, healthcare, sanitation and all the other basic needs included in the Sustainable Development Goals (SDGs), governments need tax income. But many companies use shady corporate structures, transfer pricing and other international schemes to avoid taxes. Explore how tax avoiders operate, what you can do to expose them and what kind of policies could ensure that they pay their fair share in the countries in which they operate.
